Subject: Moorpark College Football Field Lighting - Contractor site walk on 1-9-2020

The following items were discussed during our site walk held at the Football Field:

- Voltage at each of the panelboards to be replaced (at the bottom area of each pole) is 120/208 vac with the amperage as noted on the CD (contract documents) single line. All breakers will be new and match the CDs. Breakers will be bolt on type.
- Power to the panels is fed from the M & O area.
- Contractor to remove and properly dispose of the old MH fixtures.
- Contractor to focus each fixture based on a plan to be provided by the EOR.
- Lighting fixtures are per CDs with wireless control
- Two wireless hubs are to be provided, one at the north west pole base and one in the enclosed booth. Each hub requires 120 vac by contractor.
- Lighting fixtures to be mounted on the existing crossarms
- Existing cage on each pole shall be contractor removed.
- Track is to be protected from wheel damage from crane or boom truck. Any cost for repair of damage to track will be borne by the contractor.
- Contractor to provide for his own restroom facilities
- Contractor to schedule all work with the M & O director
- All RFIs and guestions shall be in writing and sent to JoNell Miller of VCCCD.
- Fixtures shall have stainless steel safety cables on fixtures to crossarms.
- Contractor is responsible for programming of the fixtures per the owner's requirements
