Properly mark the outside of the exterior envelope on your submitted bid with the <u>Bid Number and Name</u> according to the requirements stated in the bid packet directions.

If you choose not to participate in this particular bid, please sign the Bid Proposal stating "no bid" and email it back to me.

It is the responsibility of the Bidder to verify that their proposal has been received by the VCCCD Purchasing Department prior to the opening date. Verification of receipt can be made through the listed Purchasing Specialist.

The following information is in answer to questions that were submitted by email before the deadline. The deadline for questions was Thursday, January 28, 2021. No further questions will be accepted.

1. Existing conditions at building pad excavation:

Contractor shall remove all existing debris in the building excavation and dispose of in a legal manner. The resulting bottom will be surveyed and verified rough grade complies with contract documents. Excess material shall be removed off and disposed of, unless acceptable to be used as fill material for building pad. Should the resulting bottom require additional fill to bring to rough grades shown on grading plan, contractor shall import and place said material to satisfaction of the geotechnical consultant. **Bidders to provide the following unit costs as found on the <u>Bid Proposal – Addendum 2 Revision</u>:**

- 2. No substitutions for Varco Pruden wall panels and roof panels were submitted for review, therefore the Contractor shall provide the product by this manufacturer. Information about purchase/installation should be obtained directly from the manufacturer. There are no other bidding restrictions for the steel building construction/acquisition. General Contractors shall bid the entire construction project as documented on the DSA approved drawings, with the exception of Sheets GI-1 through GI-4, as the soil improvement scope has already been completed under separate contract.
- 3. For constructing the Geogrid reinforced raft, material used can be CMB or CAB, provided that the material size is 1" minus as specified.
- 4. The soil improvement sheets, G1-3, of the construction drawings, represent work that has Contractor to install sampling well per attached City of Camarillo Std Plate 7. Location is shown schematically on the attached Sewer plan, Sheet C4. Contractor shall coordinate location with Plumbing plans so that only waste from laundry is accepted in the well. Sanitary waste lines will connect to the sewer lateral downstream of the sampling well.

It is understood that the District reserves the right to reject this Bid Proposal and that this Bid Proposal shall remain open and not be withdrawn for the period of time specified in the <u>Call for Bids</u>, except as provided by law.

1.04 Award of Contract

It is understood and agreed that if written notice of the acceptance of this Bid Proposal and award of the Contract thereon is mailed or delivered by the District to the undersigned after the opening of Bid Proposals and within the time this Bid Proposal is required to remain open or at any time thereafter before this Bid Proposal is withdrawn, the undersigned will execute and deliver to the District the Agreement in the form attached hereto in accordance with the Bid Proposal as accepted within seven (7) calendar days after notification of acceptance and award. Concurrently with delivery of the executed Agreement to the District, the Bidder awarded the Contract shall deliver to the District: (1) the Labor and Material Payment Bond; (2) the Performance Bond; (3) the Drug-Free Workplace Certificate; (4) Certificates of Insurance evidencing all insurance coverages required to be provided under the Contract Documents; and (5) the Certificate of Workers' Compensation Insurance. The Work under the Contract Documents shall be commenced by the undersigned Bidder, if awarded the Contract, on the date stated in the District's Notice to Proceed issued pursuant to the Contract Documents.

Completion of the Work and all Interim Milestones shall be achieved within the Contract Time and Interim Milestones specified in the Contract Documents.

1.05 Notices

All notices or other correspondence shall be addressed to the District and the Bidder at their respective addresses set forth herein. Notices shall be effective only if in writing and in conformity with the requirements for service of notices set forth in the Contract Documents.

The Bidder shall list only one Subcontractor for each trade and/or portion of the Work as is defined by the Bidder in its Bid Proposal. If a Bidder fails to list a Subcontractor for a portion of the work in excess of one-half of one percent (0.5%) of the Bidder specifies more than one Subcontractor for the same portion of Work to be performed under the Contract Documents valued in excess of one-half of one percent (0.5%) of the Bidder's Bid Proposal amount, the Bidder shall be deemed to have agreed that it is fully qualified to perform that portion of the Work itself and that it shall perform that portion of the Work.

1.08 Confirmation of Figures

By submitting this Bid Proposal, the Bidder confirms that it has checked all of the above figures and understands that neither the District nor any of its agents, employees or representatives shall be responsible for any errors or omissions on the part of the undersigned Bidder in preparing and submitting this Bid Proposal. In the event there is a discrepancy between the bidder's written amounts and figures, the written amount will prevail.
