It is the responsibility of the Bidder to verify that their proposal has been received by the VCCCD Purchasing Department prior to the opening date. Verification of receipt can be made through the listed Purchasing Specialist.

The following information is in answer to questions that were asked via email request. The deadline for questions was Monday, March 14, 2022. No further questions will be accepted.

1Q: We do not have subcontractors and will be submitting the Subcontractors list with "N/A". Is the "Vendor" referred at the bottom of the page the same as Bidder?

1A: The List of Subcontractors form must be submitted with vendor/contractor name &

1A: The List of Subcontractors form must be submitted with vendor/contractor name & signature. Do indicate N/A if there will be no subcontractors.

2Q: Shall the Base Bid Amount (total bid amount) include sales tax? **2A**: Yes

3Q: We intend to provide a cashier's check as bid security. We do not have to fill out and submit Bid Security, Bond Section 00260 form with our proposal in this case, correct? **3A**: A cashier's check is acceptable is lieu of the bid security.

4Q: The Notice states that each bid proposal must be accompanied by: (a) the required Bid Security; not less than 10% of the maximum amount of Bid Proposal inclusive of add-on or alternates, (b) Subcontractors List, (c) Non-Collusion Affidavit, and (d) Statement of Bidder's Qualifications, all of which must be fully executed. Please confirm that Certificate of Workers' Compensation Insurance Section 00415, Drug-Free Workplace Certificate Section 00417, and Guarantee Section 00420 shall not be part of the Bid proposal to be submitted.

4A: This is accurate. Insurance certificates, Drug-Free Workplace certificate, Guarantee, & other documents will be required from the awarded contractor only.
