It is the responsibility of the Bidder to verify that their proposal has been received by the VCCCD Purchasing Department prior to the opening date. Verification of receipt can be made through the listed Purchasing Specialist.

The following information is in answer to questions that were asked at the job walk and via email request, however were not provided answers in Addendum 1. The deadline for questions was Tuesday August 8<sup>th</sup>, 2023. No further questions will be accepted.

- 1) Is this a PLA Job?
  - a) No, this is not a PLA Job.
- 2) What are the working hours for this project?
  - a) Please see Section 00800 Special Conditions 1.07 City of Moorpark Hours: 7:00 AM to 7:00PM, Monday through Friday. Saturday and Sunday require written notification to the District.
- 3) What is the duration of the Project?
  - a) Please see Section 00800 Special Conditions 1.01 One Hundred Fifty-four (154) Calendar Days.
- 4) Will the Working Area be occupied during the construction?
  - a) Access required to perform will be provided.

- 5) Will Contractor need a Job Site Trailer?a) Please see Section 00800 Special Conditions 1.18 & 1.19.
- 6) Will the District provide power?a) Please see Section 00800 Special Conditions 1.08
- 7) Does the Contractor need to perform an additional civil survey or can the Contractor work off District Civil Plans
  - a) Any additional survey information outside of the provided contract documents will need to be provided by the Contractor. Please see General Conditions Section 00700 Article 2, 2.1.1 and Article 4, 4.4.3.
- 8) What is the existing gap between the bottom rail of the existing fence and the finished surface? Please mark the location which has more than 2" gap (According to sheet C3-02 Detail 8)
  - a) Contractor to determine areas needed to be adjusted in-field during construction.
- 9) Is the footing of the light poles inside of the court to be removed?
  - a) Footings will need to be removed.
