The bid opening remains on **Wednesday**, **August 14th**, **2024**. Bids must be received no later than **3:30 p.m**. at 761 E Daily Drive, Suite 200, Camarillo, CA 93010. Properly mark the outside of the exterior envelope on your submitted bid with the <u>Bid Number and Name</u> according to the requirements stated in the bid packet directions.

If you choose not to participate in this particular bid, please sign the Bid Proposal stating "no bid" and email or fax it back to me at 805-652-7700.

It is the responsibility of the Bidder to verify that their proposal has been received by the VCCCD Purchasing Department prior to the opening date. Verification of receipt can be made through the listed Purchasing Specialist.

The following information is in answer to questions that were asked at the job walk and via email request. The deadline for questions was Friday, August 2nd, 2024. No further questions will be accepted.

1Q – Is this project under a Project Labor Agreement (PLA)?

1A - No

2Q – What are the expected working hours?

2A - 7:00 a.m. to 4:00 p.m. Monday through Friday. Saturdays, 8:00 a.m. to 4:00 p.m. upon written approval.

3Q – When is the project scheduled to begin?

3A – The start date will be after the September 2024 Board of Trustees meeting.

4Q – What are the working days in addition to the working hours?

4A - 7:00 a.m. to 4:00 p.m. Monday through Friday. Saturdays, 8:00 a.m. to 4:00 p.m. upon written approval.

- 5Q What is the anticipated duration of this project?
- 5A Please refer to the Special Conditions 00800, (180) calendar days after the date stated in the Notice to Proceed.
- 6Q Are there any specific noise restrictions we should be aware of?
- 6A Please reference 00700 4.14 Noise and Dust Control and Section 00800 1.57 for Construction Phasing. The Contractor shall be responsible for complying with the requirements of the city and county having jurisdiction with regard to noise ordinances governing construction sites and activities.
- 7Q What is the earliest allowable time to commence demolition work?
- 7A Once the Notice to Proceed is issued and the project schedule is approved. 7:00 a.m. Monday through Friday.
- 8Q Where is the designated area for material storage?
- 8A The designated are for material storage is within the project jobsite.
- 9Q Is a job site trailer necessary for this project?
- 9A No.
- 10Q Will electrical power be supplied by the school?
- 10A No. Reference Section 00800 1.08 Temporary Electric Power.
- 11Q Does the project include utility work?
- 11A Refer to the contract documents.
- 12Q Is an additional civil survey required, or can we rely on the school's civil plans?
- 12A Yes, Refer to the contract documents.
- 13Q Is there a project allowance, and should it be included in the base bid amount?
- 13A No. Please refer to Section 00800 Special Conditions.
- 14Q Will the contractor be responsible for relocating furniture, and should this cost be included in the bid?
- 14A No. Refer to sheet G0.01, all material listed within the clouded area is located south of the elevator room at the jobsite. All of this electrical, site furnishing, concrete, flooring and fencing material is to be verified and installed by the contractor.
- 15Q Will the construction area be occupied and if so, can you provide a phasing plan?
- 15A There is no phasing plan required. The limit of the project is within the construction fence. Access to the fire lane, west plaza, elevator and machine room needs to be maintained.

- 16Q Will the dumpster area be located close to the building? Please specify the location.
- 16A The dumpster is to be located within the project jobsite.
- 17Q Will the working area be occupied during the construction?
- 17A See question 15.
- 18Q Does the existing temporary fence remain? If yes, shall we include any cost for this in our bid?
- 18A The existing fence is rented by Ventura College under Marborg which only covers the existing area. Once the NTP is issued, it is the contractor's responsibility to coordinate with Ventura College FMO department in taking over the rental or coordinate the replacement of the temporary fencing with a company of your choosing. Additions or adjustments of the temporary fencing will be the contractor's responsibility.
- 19Q Is there any subsurface condition that we need to be aware of?
- 19A Yes, refer to the contract documents and GPR scan provided. Refer to the Special Conditions 00800, 1.33 Verify Existing Conditions.
- 20Q Is there any test required for completed works by the previous contractor? Please confirm that works by the previous contractor comply with the plans and specs.
- 20A All work completed by the previous contractors have been inspected and verified. All contractors are to complete the DSA form 6-C for work that they complete. Refer to the contract documents.
- 21Q Is there any permit requirement? How will we determine the related cost? Will there be an allowance for the permit?
- 21A No permit is required.
- 22Q Are there requirements to install fire alarm devices, such as strobes? If so, who is the current fire alarm provider?
- 22A Refer to the contract documents. The campus uses Integrated Fire & Safety 1229 N. Ventura Ave. Ventura, CA 93001 at 805-648-5906.
- 23Q Is an in-person fire watch required, and what are the specific days and times for it? 23A Refer to the Special Conditions 00800 1.16 Temporary Fire Protection and Safety Requirements.
- 24Q Is the synthetic resilient surfacing portion of this project bidding at this time?

- 24A Yes, the specified Mondo Sporflex Flooring under specification section 32 18 16 has been purchased and is on site. As part of Bid 681, the contractor is to install this owner furnished product as noted on sheet G0.01.
- 25Q-Is the team considering sustainable off-grid power solutions for lighting, wifi, or security?
- 25A Refer to the contract documents.
