New Information and Forms

A new revised Bid form and Pricing form is attached Bidders should only submit bid forms and pricing forms with 10/27/20 revision date.

The Bid due date is now extended to 12:00 noon, Friday, November 6, 2020.

<u>Changes to Bid Form:</u> Page 1 has been revised to correct the Bid Addenda Acknowledgement. New Revised form will show 10/21/20 as the revisions date.

<u>Changes Pricing Form:</u> The revised pricing form shows the Intrepid 4 x 5 Large Format and the Canon EOS Mark II cameras and accessories removed from the bid. The revised form also has been broken into 5 sections. Section 1 and 2 are for new equipment and accessories, sections 3, 4 and 5 are for used equipment. Used equipment bid forms must be accompanied by a vendors grading system, including an explanation of how a vendor grades the equipment for resale.

Example A to E condition, A = New, B = Like New C = used but with scratches, etc. or 1 through 10 where 10 = new and 1 = very used and possibly in need of a lot of repair.

A Bidder must respond to all items in a section to be considered.

Bidder should attach back up materials on grading system and warranties or other information to the pricing form.

Minority-Owned/Disadvantaged Business

A small business concern which is at least fifty-one percent unconditionally owned by one or more socially and economically disadvantaged individuals, or, in the case of any publicly owned business, at least fifty-one percent (51% of the stock of which is owned by such individuals, and whose management and daily business operations are controlled by one or more of such individuals).

Business owners who certify that they are members of named groups (African American, Hispanic Americans, Native Americans, Asian-Pacific/Asian Indian Americans) are considered socially and economically disadvantaged.

Woman-Owned Business

A business concern that is at least fifty-one percent (51%) owned by a woman or women who also control and operate it. "Control" in this context means exercising the power to make policy decisions. "Operate" in this context means being actively involved in the day-to-day management.

Small Business Concern
